PRE-EMPLOYMENT MEDICAL EXAMINATION (PEME) CLINICS IN THE PHILIPPINES

Reference is made to Circular No. 11/04 of May 3, 2004 which announced the inception or the American Club's program for the approval of clinics performing Pre-Employment Medical Examinations (PEMEs) in the Philippines.

As the Club marks the anniversary of this initiative, it is pleasing to note that the program is estimated to have led to the prevention of illness-related claims among Filipino seafarers of somewhat in excess of \$1 million by value over the last twelve months.

Taken together with the results of Ukrainian clinics as reported in Circular No. 08/05 of March 28, 2005, a total of some \$2.25 million by way of seafarer illness claims would appear to have been averted by virtue of these PEME programs over the last year.

However, your Managers have noted that the level of Member uptake in regard to use of the Club's PEME program in the Philippines is significantly less than that which applies to its scheme in the Ukraine. In light of the highly encouraging results obtained by taking advantage of the Club's approved clinics as described above, Members employing Filipino crew are urged to avail themselves of these medical facilities so as to ensure to the maximum extent possible the health of crew employed on board their vessels.
